General Overview

Executive Summary

On March 11, 2021, the American Rescue Plan Act (ARPA) was signed into law and established the Coronavirus State and Local Fiscal Recovery Funds (SLFRF) program. The program is intended to support state, territorial, local and Tribal governments in their efforts to address the economic and public health impacts of COVID-19 on our communities, residents and businesses.

In response to the COVID-19 public health emergency, the County of Hidalgo applied for its allocation of the SLFRF program and was granted a total of \$212,973,405.00. The County of Hidalgo received half of the allotted funds in June 2021. The second tranche was received in June 2022.

The Hidalgo County Department of Budget and Management established its American Rescue Plan Act Program in September 2021. The program performs comprehensive reviews of guidance provided by the U.S. Department of the Treasury, prepares materials in response to requests for program information and executes required reports. Additionally, the Hidalgo County ARPA Section is responsible for project analysis, planning, development and implementation.

Hidalgo County's American Rescue Plan Act Program functions as the core of the County's SLFRF program management and works to enable COVID-19 mitigation tactics and economic recovery efforts. The Hidalgo County American Rescue Plan Act Program is committed to maintaining accountability and transparency as it addresses the health and economic impacts of the COVID-19 public health emergency.

In accordance with the U.S. Department of the Treasury's Compliance and Reporting Guidance, the Hidalgo County 2023 Recovery Plan Performance Report has been developed to inform the public and U.S. Treasury of Hidalgo County's SLFRF projects. All current and past Project and Expenditure Reports and Recovery Plan Performance Reports are available via the website.

Hidalgo County Recovery Plan Performance Reports detail the scope of current and past SLFRF projects, expand upon the County's efforts to engage the community and underscores the importance of abiding by guidance provided by the U.S. Treasury in order to ensure an efficient, equitable and effective recovery from the COVID-19 public health emergency.

The State and Local Fiscal Recovery Funds (SLFRF) program allocation allowed Hidalgo County to begin its strategic development plan to expeditiously respond to the COVID-19 public health emergency. The SLFRF, which supports state and local governments' response to COVID-19 and its effects, has allowed the County to take a dedicated and intentional approach to addressing the COVID-19 public health emergency's disproportionate impacts on County residents. Simultaneously, federal funds have also granted the opportunity to respond to the long-standing socioeconomic disparities among underserved communities.

Since its inception, the Department of Budget and Management American Rescue Plan Act (ARPA) Program has strategically operated to expend funds in compliance with the SLFRF Final Rule and Compliance and Reporting Guidance. The program is currently overseeing the expenditure of funds and ensuring that projects are executed in a manner that are equitable, efficient and effective.

In 2021, the County of Hidalgo launched efforts for economic recovery by prioritizing public health services , healthcare initiatives, public safety measures, recreational development and improvements to stormwater systems. Public health measures continue to be the focal point of the County's COVID-19 recovery. Meanwhile, projects aimed at addressing recreational spaces in Qualified Census Tracts (QCTs) and stormwater systems promote healthy lifestyles, public safety and an improved quality of life in the community that is sustainable and benefits all.

Project requests are submitted electronically. In addition to adhering to the SLFRF Final Rule and Compliance and Reporting guidelines, project selections are based on targeted principles aimed at primarily serving our most vulnerable populations residing in Qualified Census Tracts (QCT).

Hidalgo County has two primary goals; to provide assistance to its residents and to provide support for the community, particularly the disadvantaged population who have suffered the most through the pandemic as such the mission, vision and values are as follows:

Mission:

To serve constituents by building a strong and healthy community through continuous engagement, assistance and access and/or distribution to adversely affected groups in Hidalgo County.

Vision:

Hidalgo County will provide efficient government services for long lasting investments, rebuild reserves to enhance financial stability, leading the community toward success.

Values:

Integrity Demonstrating honesty, trustworthiness and sincerity at all times

Excellence Providing exceptional service and surpassing expectations

Equity

Providing fair, impartial assistance to individuals who are served by the county

Innovation Striving for better ways to serve constituents, employees and the county as whole

Transparency

Accounting of all facts, information and ensuring equitable decision-making



Uses of Funds

As Hidalgo County began the process of planning how to utilize CSLFRF funds to better serve constituents by building a strong and healthy community, internal program implementation and the ARPA Section was developed to maximize the programmatic efforts in order to achieve effective, efficient, and equitable outcomes. Eligible uses of funds integrated with the specific needs of Hidalgo County and its constituents will allow the County to better support and serve the community for a resilient future.

Hidalgo County's approach in supporting strong and equitable recovery is to focus efforts and offer assistance to communities that have been impacted the most by the pandemic, the most vulnerable populations. Research into the Social Determinants of Health indicate areas of priority that require assistance because they have an impact on a person's health, well-being, and quality of life along with social, physical, and economic conditions. Hidalgo County's mission is to provide excellence and innovative ways for the proposed projects to achieve the assistance, access and/or distribution to adversely affected groups. To provide efficient government services for long lasting investments and further assist with the Social Determinants of Health, the following sections have been prioritized.

The spending amounts remain relatively consistent but flexibility is allowable as the Court understands that recovery efforts are imperative for the community. The outcomes intended are focused on closing gaps between disproportionately impacted communities and to reach subpar levels of service to the community as a whole.

Treasury has requested that recipients showcase how specific Expenditure Categories are being prioritized. Hidalgo County will demonstrate areas of priority have been identified in the Expenditure Categories, as defined by the Treasury.





Public Health (Expenditure Category 1)

In 2021, Hidalgo County began a comprehensive response to the COVID-19 pandemic and its impacts on the public health system. Efforts included investing in health care access in indigent communities, addressing congregate settings in County workspaces and jails and strengthening the County's response to COVID-19. Currently, the County is no longer utilizing a mobile unit for COVID-19 operations. The County is continuing to mitigate the spread of COVID-19, especially in jails by transferring inmates to other facilities in order to alleviate overcrowding. Recently, the County has reinforced COVID-19 prevention efforts in the Hidalgo County Adult Detention Center by hiring five additional medical assistants. The medical assistants provide crucial medical services to inmates in the event of a COVID-19 infection or other illness. Moreover, the County has retrofitted the new Hidalgo County Courthouse with COVID-19 prevention equipment and enhancements, including antimicrobial heating, ventilation along with cooling systems and hands-free functionalities in restrooms and congregate areas.

In 2022, the County outlined measures to increase access to health care in indigent communities, including improvements to Hidalgo County Health Department clinics and assistance to non-profit clinics. The County Health Department clinics that are receiving assistance via the CSLFRF program are the Hidalgo Clinic and Mission (Schuerbach) Clinic. The County was in the preliminary stages of reopening a defunct clinic located in Precinct 3, however, the Mission (Schuerbach) Clinic was rescinded because it was deemed unsafe to improve due to foundation and site issues. Beyond improvements to clinics, funds were granted to nursing schools for instructor retention incentives in order to increase the number of graduating nurses in Hidalgo County.

The County is also enhancing its emergency response capabilities by investing in emergency response equipment to administer services during peak operating periods, such as COVID-19 case surges. The ability to timely and aptly respond to emergencies is an essential aspect of government services. Additionally, Hidalgo County has acquired a vehicle outfitted with pre-hospital medical equipment intended for medical services to homebound individuals, the elderly and populations with disabilities. Services will primarily focus on communities that have been disproportionately impacted by COVID-19. Finally, the County is also obtaining a patching system to improve communication response efforts and collaboration with radio communication among County emergency responders.

Furthermore, the County is planning to extend CSLFRF to provide a future emergency management facility with the necessary equipment, means and retrofits to operate under emergency situations. This project remains in the preliminary stage. Hidalgo County is funding emergency management personnel to provide and implement emergency preparedness, coordinate training programs and emergency operations that will prepare the county for best



outcomes during emergency situations and an overtime program, which remunerates employees who are directly responding to the COVID-19 public health emergency.

The Hidalgo County Health Department has undertaken an initiative to electronically store COVID-19-related documentation, such as vaccination and testing records. The County procured software to assist in this initiative and employed a team to scan and enter the documents into the new system. The Health Department has adapted to COVID-19 era precautions by acquiring software to enhance cybersecurity for employees working remotely. Hidalgo County is enhancing its cybersecurity capabilities for employees working remotely due to the COVID-19 public health emergency.

To continue the outlined measures to increase access to health care in indigent communities, further improvements and a new construction for a clinic has been deemed necessary. The County Health Department clinics that are receiving assistance via the CSLFRF program also include the Edinburg Health Center, Weslaco Health Center and a new construction for a clinic: La Mansion Health Clinic. These projects remain in preliminary development.

To continue addressing health inequities and create more sustainable communities, Hidalgo County will continue investing in public health projects that will protect a person's health, well-being, and quality of life.



Negative Economic Impacts (Expenditure Category 2)

The COVID-19 public health emergency has collectively impaired the psyches of Americans. Pandemic-related stress has exacerbated behavioral health difficulties, depression, anxiety and substance use. In response, parks along with hike and bike trails have become platforms for exercise and mental relief. The County is utilizing funds to enhance and/or improve amenities that will promote healthier living environments by allowing accessibility to safe and socially distanced recreational areas in disproportionately impacted communities to improve the mental and physical well-being of residents. Additionally, in order to foster a resilient and equitable economic recovery, Hidalgo County is addressing the impacts of the COVID-19 pandemic on vulnerable populations. Measures taken to assist those who suffered the worst of the pandemic align with the County's goal of promoting equity among communities.

The County assisted a struggling emergency services (EMS) provider by contributing a portion of its CSLFRF allocation. Although the EMS provider experienced the negative economic impacts of the pandemic, it continued to service County residents. The assistance provided to the EMS provider will allow it to continue to provide lifesaving services to residents, especially those living in unincorporated areas of Hidalgo County.

In response to the collective grief endured by students in Hidalgo County schools due to COVID-19, the County is partnering with school districts to create programs that promote wellness and mindfulness among low-income and disadvantaged students.

In addition to providing mental health services to the County's youth, the County is also promoting wellness among children by assisting two non-profit organizations. The assistance will allow the non-profits to continue providing educational and behavioral health services to children in Qualified Census Tracts. Investments in the behavioral health and education of the County's youth are critical in their emotional and physical development.

Families across the County have endured the indiscriminate and harsh negative economic impacts of the pandemic. The County plans to provide small repairs and rehabilitation housing assistance to a non-profit organization that services low-income individuals and families experiencing homelessness in *colonias*, residential areas along the Texas-Mexico border that may lack basic living necessities such as, potable water, septic or sewer systems, electricity, paved roads or safe and sanitary housing. Individuals and families in *colonias* are in need of support, and the program will bring much needed improvements to homes in unincorporated areas of the County.

Housing insecurity continues to affect many low-income households in Hidalgo County, due to the economic impact of the pandemic. A project has been proposed to assist approximately 250 affected families to maintain housing stability by providing rental assistance, prevent eviction and decrease the risk to homelessness to the most vulnerable population.



Additionally, various parks in disproportionately impacted areas within Precinct 3 continue to be identified. Meanwhile, J.R. "Milo" Ponce Park, located in Precinct 4, has been completed and now the park has replaced existing playground amenities with modern, more inclusive equipment for children aged 2 to 12 years and measures will be taken to improve accessibility. The County rescinded the action to improve and fund Precinct 4's Pueblo de Palmas Park due to other funds being allocated and appropriated to this project.

Substantial developments will be made to Lopezville Park in Precinct 2. The proposed improvements include soccer fields, inclusive playscapes, basketball courts, tennis courts, walking trails and a fishing pond, all of which will improve social determinants of health in, near and around the park.

Moreover, significant investments will be made in hike and bike trails located within Precincts 1 and 2. The developments made in the trails are a part of the County's goal of improving the mental health of the County by addressing social determinants of health in disproportionately impacted communities. The ARPA Section's goal is to reimagine public spaces and create access for constituents to discover hidden gems within Hidalgo County. Precinct 2 trails will be extended to connect to trails in the Cities of Hidalgo, McAllen and Mission. Meanwhile, a new trail will be developed in the Mid-Valley area of Precinct 1. The Precinct 1 trail will travel through the Cities of Alamo, Donna, Mercedes, Pharr and Weslaco.

Hidalgo County intends to construct a community resource center alongside a health clinic. The community resource center will improve the well-being of disproportionately impacted communities through workforce assistance, educational services, child care and access to assistance and support services to meet the needs of the constituents.

Hidalgo County will continue investing in projects that promote healthier living environments particularly, those that have been impacted and have experienced negative economic impact.



Public Health-Negative Economic Impact: Public Sector Capacity (Expenditure Category 3)

The COVID-19 public health emergency severely damaged Hidalgo County's local economy and disproportionately impacted populations. As result, projects designed to assist with effective service delivery, administrative needs, and the public workforce were placed as a priority. To maintain social distancing guidelines, the County is continuing the use of Google Suites and obtained a new human resource management system to reduce the need for in-person attestation and, by default, assist with COVID-19 mitigation efforts. Streamlined data processing is essential to the County as a whole as connectivity and uptime are crucial to the departments that require immediate actions, thus requiring a data system that is updated and cloud based. A project is being led for the integration and implementation of a system that will allow for more efficient operations.

Access to the internet and information has been on the forefront of Hidalgo County's goals. It became apparent during the pandemic, as schooling migrated online and work became remote, Hidalgo County launched a broadband feasibility study to survey and monitor the access to internet in the unincorporated, underserved or unserved areas to maximize resources and expand broadband capability to those areas.

Additionally, a program was developed to assist with the need for overtime hours throughout Hidalgo County for employees working directly relating to the pandemic. Incentives such as economic remuneration would assist with retention of employees.

To specifically assist in the emergency preparedness of Hidalgo County, a Deputy Management Coordinator position was created. This position would include but not limit to the coordination of training programs, emergency operation drills, and assist departments with their emergency and mitigation plans. Administrative support was needed due to the ongoing demands of the pandemic.

Further personnel may be needed to assist disproportionately impacted communities and assist constituents with benefits and/or services throughout the ongoing public health emergency.



Premium Pay (Expenditure Category 4)

In 2021, Hidalgo County authorized premium pay programs for County, Community Service Agency and Drainage District regular full-time, regular part-time, temporary full-time, and temporary part-time employees who were hired in person on or before August 1, 2021.

The purpose of the programs was to provide pay to eligible employees who have been, and continue to be, relied on to maintain the operations of essential, critical infrastructure sectors, including those who are crucial to protecting the health and wellbeing of their communities; employees teleworking from a residence are not eligible to receive Premium Pay. Premium Pay has been awarded at a rate of \$13.00 per hour in addition to regular wages. Premium Pay should not exceed the tiered amounts of \$3,500.00 for eligible employees earning up to \$40,000.00, \$3,000.00 for eligible employees earning between \$40,001.00-\$60,000.00, and \$2,500.00 for eligible employees will receive 50% of the \$13.00 per hour pay rate once approved hours are met.

All three programs are complete for the year 2021.

In 2022, Hidalgo County authorized a second set of premium pay programs for County, Community Service Agency, Head Start and Hidalgo County Drainage District regular full-time, regular part-time, temporary full-time and temporary part-time employees who were hired in person on or before June 1, 2022.

The Community Supervision and Corrections Department was added to the Premium Pay Program, with the same guidelines and requisites. All four programs are complete for the year 2022.



Infrastructure (Expenditure Category 5)

The U.S. Treasury's CSLFRF final rule allows state and local governments to expend funds to enhance existing storm and wastewater infrastructure in order to recognize and address areas of critical need. Hidalgo County has an array of areas with limited or no access to clean water or viable stormwater systems. The aforementioned areas are often susceptible to flooding during rainy seasons. Most notably, low-income and minority communities often encounter considerable water inequities, such as increased lead exposure and risk of infection from exposure to fecal matter. All in all, the streets, avenues and main roads of Hidalgo County are affected by the collapsed drains. The flooding caused by inadequate stormwater systems damages homes, harms constituents, destroys property, spreads disease and erodes roads. To address the health and equity in the County, the ARPA Section is launching a dedicated effort to provide efficient stormwater management.

The County plans to address health inequities by investing in wastewater and stormwater infrastructure in the following areas:

Hidalgo County will continue its innovative Wi-Fi accessibility initiative via the ARPA Section. Wi-Fi became more significant and utilized through the pandemic. In response to the increased need for stable Wi-Fi access due to challenges brought by the COVID-19 public health emergency, the Hidalgo County ARPA Section has made dedicated efforts to increase Wi-Fi accessibility through last-mile projects and replacing and/or restoring County Wi-Fi poles. Hidalgo County's goal is to provide fair, impartial assistance to the constituents who require reliable high-speed internet access for work and learning.

To continue addressing health disparities and provide services for long lasting investments, Hidalgo County will continue its efforts in wastewater, stormwater and broadband infrastructure projects.





Provision of Government Services (Expenditure Category 6)

In order to continue providing services which are intended to serve all members of the community, Hidalgo County invested in essential government services and emergency operations. Government services include any service traditionally provided by the County, which include construction/improvements to infrastructure, modernization of technology, provision of public safety and other services, health services and necessary retrofits for County equipment and facilities. Proposed projects for the upcoming year will include several General County Operations that will assist the employees of the County as well as the constituents alike.

Addressing health inequities and creating more sustainable communities continues to be a priority for Hidalgo County to provide exceptional service and surpass expectations, Hidalgo County will continue investing in wastewater and stormwater infrastructure projects.





Promoting Equitable Outcomes

Goals

Hidalgo County's recovery efforts are developed to provide access, opportunity and outreach to all. Key principles that are taken into consideration are race, class, age, and gender. All the aforementioned factors have played a role in the experiences of impacted and disproportionately impacted communities. The majority, Latino population, located in disproportionately impacted areas had their historical inequities exacerbated.

In accordance with the federal government's Executive Order 13985, which focuses on advancing equity to underserved communities, Hidalgo County has taken a dedicated approach toward the equitable use of CSLFRF. The Hidalgo County ARPA Section is devoted to addressing socioeconomic inequities across all races and classes. Efforts are not focused on providing the same services among all constituents; rather, projects will yield resources and opportunities to leverage outcomes experienced by groups that do not experience the same socioeconomic disparities, such as lack of access to recreational spaces, broadband internet and serviceable stormwater management systems.

In sum, equity goals outlined by the Hidalgo County ARPA Section serve to bridge long-standing gaps in government services. Hidalgo County established an equity framework to facilitate its goal of promoting equity.

In response, equity focused initiatives that provide mental health services, COVID-19-related care and general health care are set to be based in Qualified Census Tracts. Households in Qualified Census Tracts are designated by the U.S. Department of Housing and Urban Development as areas in which must have 50% of its households with incomes below 60% of the area median gross income. The County's direct assistance to underserved populations addresses equity by increasing accessibility to basic government services.

Awareness

Hidalgo County launched a centralized and systemic communications effort for all CSLFRF projects. To gain perspective on community needs, several outreach strategies were placed for data collection. First, the ARPA Section website contains an intake survey where respondents provided qualitative data; the survey was also disseminated via social media. The survey was open to individuals, households, small businesses, non profit organizations and other entities. Second, the County engaged with local radio and television stations to reach individuals that may not have internet access. Lastly, our residents may access our contact information (Email and phone) on our website to inquire on program services and eligibility.



Access and Distribution

Populations in Hidalgo County face significant barriers in accessing government services and communication. According to the U.S. Census Bureau almost 30% of the population does not have access to broadband internet, and the federal government's Education & Labor Committee reports a 50% literacy rate. As projects reach milestones, the Hidalgo County ARPA Section has circulated information on the County's social media channels and website. The ARPA Section also has an email listing in which subscribers receive CSLFRF news electronically. Information is communicated in English and Spanish and accommodations are available upon request. Constituents may contact the Hidalgo County American Rescue Plan Act Section at any point via Email or phone to inquire on program services and eligibility.

Outcome

The County intends to bridge gaps in government services by centralizing projects in areas of greatest need and prioritizing services that optimize support and resources. Stormwater system improvement projects are at the forefront of the County's initiatives to alleviate the effects of stormwater and improve public health outcomes. Equity will be measured at different points based on completed projects and the social determinants of health.

Several recovery projects are close to completion and have specific geographic locations and the demographic in need. For example, as a part of the mental health initiative to help youth, two school districts have piloted Wellness Camps with ARPA allocations to address and respond to mental health disparities which have resulted from the pandemic. Similarly, assistance to impacted non-profit entities has been provided. The goal of one entity was to continue their efforts to provide food assistance to low-income families. Assisting low-income families and communities with Behavioral Health through clinics is imperative to the other entity. Hidalgo County has geographical locations that have needs as many areas are Qualified Census Tracts (QCT) or Low-to-Moderate Income Areas.



Community Engagement

Hidalgo County is devoted to engaging the community in its effort to recover from the COVID-19 public health emergency and its negative impacts. In 2021, the County launched a survey (English and Spanish) to gather public opinion on the impacts of COVID-19 in Hidalgo County. With a predominantly 92.5% Hispanic population and a 33.5% poverty level, the County received a variety of responses and is continuing to allow submissions.

At this time, survey respondents rate limited health care access and limited access to broadband internet as the greatest disparities exacerbated by the COVID-19 pandemic. In order to address concerns expressed by the community, the County plans to implement projects that respond to the aforementioned socioeconomic inadequacies. The forthcoming projects not only address socioeconomic disparities, but also promote equitable outcomes among residents.

Hidalgo County is investing in capital expenditures in County clinics to increase access to public health care: the El Paraiso and new Mission Clinic in Precinct 3, the Hidalgo Clinic in Precinct 2, The Weslaco Clinic in Precinct 1, and the Edinburg Clinic in Precinct 4. The improvements to the clinics will promote equitability and increase residents' access to vital health services amid the COVID-19 public health emergency. In addition, the County is also providing assistance to non-profit clinics that aid indigent populations.

Wi-Fi and broadband access have become vital to working and learning amid the COVID-19 public health emergency. In response to the County's lack of serviceable broadband internet connection, the ARPA Section is preparing a slew of projects that directly increase broadband access in areas that need it most. Projects include replacements of County Wi-Fi service poles and efforts to improve Wi-Fi in last mile areas.

Moreover, constituents reached out to County Precinct Commissioners for assistance with stormwater initiatives due to the county's problematic flooding history. Approximately 60% of SLFRF funding will be utilized to improve social determinants in order to improve health outcomes.




